Middle School (Grades 6 - 8): <ul style="list-style-type: none"> ● Continue Option A - Hybrid Instruction (4 days face-to-face; 1 day remote) ● Continue with Option B - 100% Virtual
High School (Grades 9 - 12): <ul style="list-style-type: none"> ● Maintain Option A - Hybrid Instruction (4 days face-to-face; 1 day remote) ● Continue with Option B - 100% Virtual
